#### **New Business**

Subject: Frank discussed the issue of Voting at meetings. Voting on positions involved an attendance requirement

Voting in general has been defined under the \$35 membership fee, but this has been changed now which raises the question of "who is a member?"

Open discussion on how to proceed:

- Val proposes, attendance should still be factor, for example at least 2 per year
- Vanessa proposes registered and paid for admin fee for sports you are involved in, are eligible for votes in all but 'big ticket items'
- Refunds in spring do not retract membership
- Caveat would be that we need to cross check any votes to paid admin fees

*Motion to*: To vote, an individual must have paid their 'annual fee 35\$ even if refunded, admin fee for fall and moving forward, or be a volunteer for the organization" Made by Megan, Second by Frank- No objections

Subject discussion: Currently Weisenberg Elementary is full virtual due to cases of Covid-19 Motion was made that students from a closed school should be excluded from participating in sports until the school is reopen, DO we need or want to put something in place for the NYAA level. Below is the discussion period.

- Vanessa- Wants to mirror the school athletic policy that would prohibit the closed school from participating.... Just wants to address Jessica's one question, the intent of the waivers is to protect us as a board and organization... do we have a liability to protect the organization and members.. My opinion is that is it willfull negligence to not closed for the school involved.
- Kevin Proposed- If school goes full virtual will sports continue.
- Val- agrees but adds that this should not be inclusive to the closed school at the elementary level and would not do that with the cheer program,
- Erin- from softball, has 2 teams invested, not effected, but does not feel they should be forced to close a team for the school closing. Only thing kids have normal in their kids
- Jen Agrees with Erin, as a parent of a child on the baseball team and they signed a form accepting responsibility and it is their choice to take their children. We should continue to play on. We signed legally that we are taking responsibility
- Stan Trella- Agrees with Jen and Erin. Let them play
- Sue D- Agrees with Val. Can and should pause our programs
- Jess- It is always in our community

- Scott- This is not a do we play or do we not play. Do we make a choice that if a school is closed
  do, we not play? Sibling, older kids, regardless of what school closes there is still a chance of
  exposure. We have a process and guidelines and parents should have a choice, but will people
  make a choice of sport over covid. It is not fair to put this all on the Director, feels it should be
  as an organization
- Erika- If we have this where we close to a school, I don't see how sports will continue. We would essentially shut down sports. AAU is going on without a hitch, tournament is occurring without a hitch. Sports are continuing outside of the school.
- Dave- has have varying opinions—was fine with 5 days. Don't have all of the facts... and school shut for 14 days when they don't have the increased cases.
- Rich- Football coach for the highschool- got a call the same day if you were ok to go to school or not. 3-5 days sound pretty fair. If you were in that class you would have received notification.
   Recommendation that it should be at the sport/team level.
